Russel, 555 Pa. 398, 725 A.2d 355 (1999), the plaintiff suffered head injuries in an automobile accident. As a result of the accident, he suffered from a schizophrenic reaction and was repeatedly institutionalized. The defendant insurer disputed coverage under the plaintiff's auto insurance policy, arguing that the plaintiff did not have coverage because the mental illness was a "sudden" and "unexpected" incident. The Supreme Court rejected this argument, noting that the sudden illness was not, as the defendant insurer suggested, "unforeseen." Rather, "it was as readily expected as the more common injuries which, even though unforeseen, give rise to insurance protection."

Id., 555 Pa. at 409, 725 A.2d at 360. In discussing the effect of the definition of "sudden," the Court stated that: The term "sudden," as used in these policies, will logically be understood to mean unexpected. Injuries are not sudden when they are "readily foreseeable." Nor would it be reasonable to construe the term so that it meant unintended, since if that were so there could be no accidents, and "accident" is defined to mean an "unexpected or unintended incident or consequence." Id. Thus, the Supreme Court concluded that the "sudden illness" was insured under the plaintiff's *952 auto insurance policy, finding that the injuries were "unexpected" and "readily foreseeable." In this case, the trial court reached the same conclusion. The trial court found: 4. It was not a surprise to Plaintiff that the alleged accidental fall by the cat occurred.
